If anyone in my application group is found eligible for MaineCare, I authorize the Office for Family Independence to pursue and seek to collect any money from other health insurance, legal settlements, or other third parties that may be legally responsible for paying any health care received by me or members of my applicant group. I am also authorizing the Office for Family Independence rights to pursue and obtain medical support from a spouse or parent.

What should I do if I think my eligibility results are wrong?

If you don't agree what you qualify for, in many cases, you can ask for an appeal. Please review your eligibility notice to find appeals instructions specific to each person in your household, including how many days you have to request an appeal. The following information is important to consider when requesting an appeal:

- You can have someone request or participate in your appeal if you want to. That person can be a friend, relative, lawyer, or other individual. Or, you can request and participate in your appeal on your own.
- If you request an appeal, you may be able to keep your eligibility for coverage while your appeal is pending.
- The outcome of an appeal could change the eligibility of other members of your household.

To appeal your eligibility results, complete and return the Appeal Request Form available on **CoverME.gov**. You can appeal eligibility for purchasing health coverage through **CoverME.gov**, enrollment periods, tax credits, cost-sharing reductions, or Medicaid, if you were denied these.
